Subject: Guidelines for implementation of Revised IS/IEC 60669-2-1: 2021

- 1. The product 'Dimmers for LED products' falls under the scope of IS/IEC 60669-2-1: 2008 'Switches for Household and Similar Fixed Electrical Installations Part 2 Particular Requirements Section 1 Electronic Switches'. The product is covered under mandatory certification under Scheme II of Schedule –II of the BIS (Conformity Assessment) Regulations, 2018. As on date there are 12 licences for the product under Scheme –II of Schedule –II of the BIS (Conformity Assessment) Regulations, 2018.
- 2. The Indian Standard IS/IEC 60669-2-1: 2008 has been revised to IS/IEC 60669-2-1: 2021 'Switches for Household and Similar Fixed Electrical Installations Part 2 Particular Requirements Section 1 Electronic Switches (First Revision)'. The last date for concurrent running for both the Indian Standards has been extended to 12 October 2024 after which the existing IS/IEC 60669-2-1: 2008 shall stand withdrawn.
- 3. As on date there is 1 laboratory recognized for under LRS for IS/IEC 60669-2-1: 2021.
- 4. The guidelines for implementation of the revised Standard is given below:

A. For Existing licensees as per IS/IEC 60669-2-1: 2008

- (i) All existing licencees shall switchover to the IS/IEC 60669-2-1: 2021 by 12 October 2024. Beyond 12 October 2024, no licence shall be operative where compliance to IS/IEC 60669-2-1: 2021 has not been ensured by the licencee. The status of implementation of the amendment shall be confirmed by Registration Department to CMD-III within two weeks of the last date of concurrent running.
- (ii) Existing licencee shall submit conformance to IS/IEC 60669-2-1: 2021 through complete Test Report(s) issued by BIS recognized laboratory for all the lead model(s) from existing scope of licence which had been previously tested as per IS/IEC 60669-2-1: 2008.
- (iii) Further, the licencees shall provide an undertaking stating that requirements of IS/IEC 60669-2-1: 2021 have been implemented in all other existing series model(s) which are in the scope of the licence.
- (iv) If the licensee fails to complete all actions by 12 October 2024, cancellation of the licence/deletion of model from scope of the licence to be initiated.

B. For New Applicants:

- (i) The existing applications which are under process as per IS/IEC 60669-2-1: 2008 shall be processed as per existing guidelines provided that the applicants submit an undertaking that they shall changeover to the revised IS/IEC 60669-2-1: 2021 before the last date of implementation, i.e. 12 October 2024.
- (ii) Applications which are recorded henceforth may be processed as per existing IS/IEC 60669-2-1: 2008 or as per revised IS/IEC 60669-2-1: 2021. However, processing of applications as per existing IS/IEC 60669-2-1: 2008 shall be permitted only upto 12 October 2024 and for such cases applicants shall give a declaration that they will implement the revised Indian Standard by 12 October 2024.
- (iii) No new applications are to be accepted as per existing IS/IEC 60669-2-1: 2008 after 12 October 2024.
- (iv) If any Licensee/ Applicant fails to complete all actions by 12 October 2024, the Licence / Application may be processed for cancellation/ deletion of model from scope of the licence.

C. For Change in Scope of Licence:

- (i) For change in scope of licence, the relevant provisions as given above for applicants shall apply.
- (ii) However, processing of such applications for change in scope of licence as per existing IS/IEC 60669-2-1: 2008 shall be permitted only upto date of implementation of revised Indian Standard by the licencee or upto 12 October 2024, whichever is earlier.
- 5. The above guidelines shall come into force with immediate effect.
