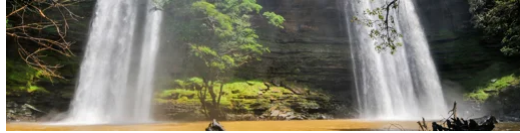

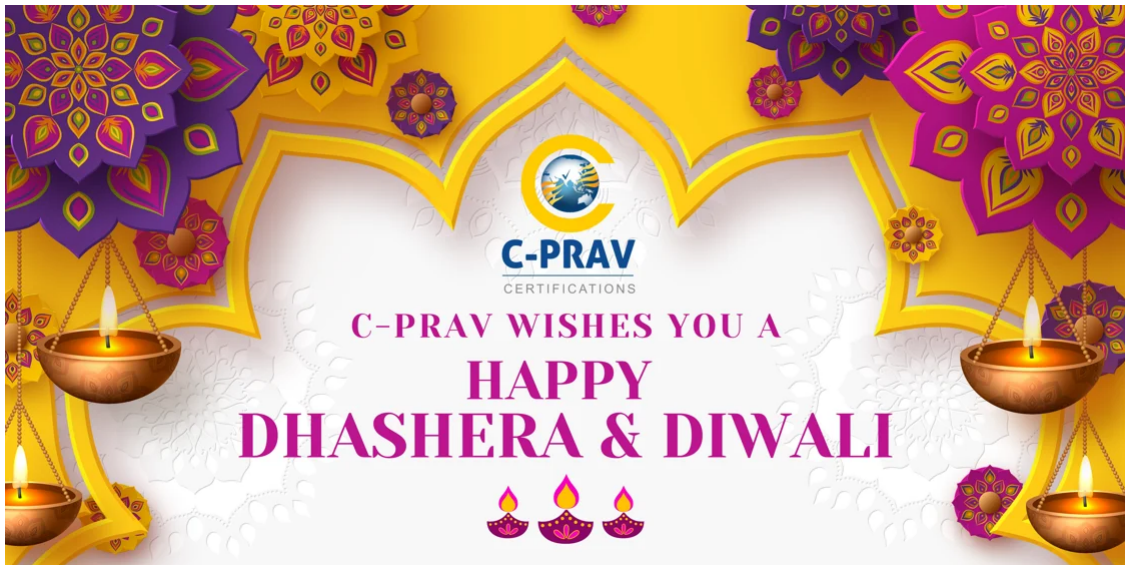

The focus was on EMF (RF Exposure) testing standards for wireless devices and networks. This collaborative effort aims to establish the latest test methods for cutting-edge technologies, including standards such as IEC/IEEE 62209-1528, IEC/IEEE 62209-3, IEC/IEEE 62704, IEC/IEEE 63480,
