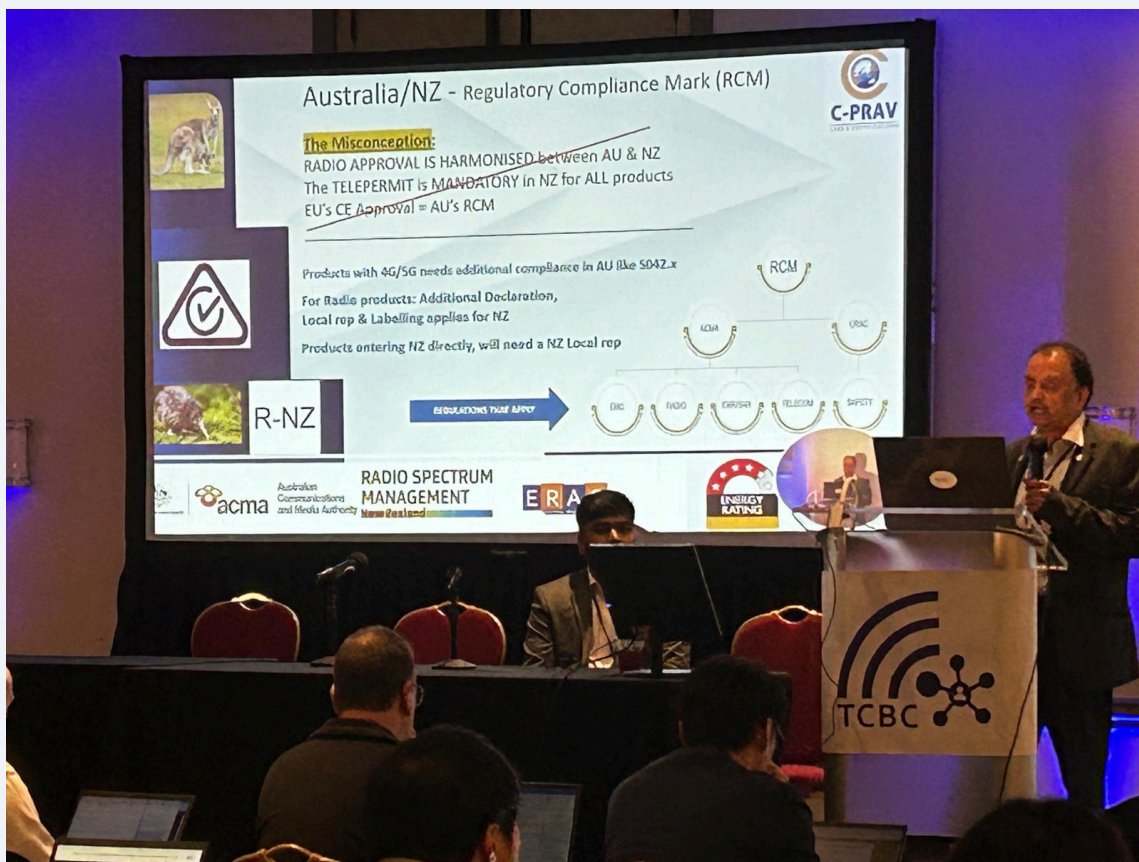
# C-PRAV at the TCB Council Workshop **this week** in Baltimore, USA
